INTRODUCTION

CHALLENGES

- Implementing Peru Localization features within the Global processes as well as the e-Billing program
- · Fit in local legal requirements into corporate processes
- Dependency on data also had an impact on 3rd party interfaces requiring 4 rounds of testing to be performed
- ERP resided on corporate environment and had to be moved to dedicated servers, involving all client's ecosystem interfaces like costing, HR, Sales, Direct Purchases, etc.
